INTRODUCTION

The purpose of this circular is to provide you with information regarding the following resolutions to be proposed at the AGM relating to: (i) grant of the Repurchase Mandate to the Directors; (ii) grant of the Issue Mandate to the Directors; and (iii) the proposed re-election of retiring Directors.

LETTER FROM THE BOARD

THE REPURCHASE MANDATE

As approved on the last annual general meeting of the Company held on 25 May 2018, a general unconditional mandate was granted to the Directors to exercise the powers of the Company to repurchase Shares representing up to 10% of the total number of Shares in issue as at the date of passing the relevant resolution. Such mandate will lapse at the conclusion of the AGM.

An ordinary resolution will be proposed at the AGM to grant the Repurchase Mandate to the Directors. As at the Latest Practicable Date, the Company has an issued share capital of HK\$20,250,000 divided into 2,025,000,000 Shares of HK\$0.01 each. Subject to the passing of an ordinary resolution to approve the Repurchase Mandate at the AGM and on the basis that no further Shares will be issued, allotted or repurchased by the Company prior to the AGM, exercise of the Repurchase Mandate in full would result in up to a maximum of 202,500,000 Shares, representing 10% of the total number of Shares in issue and a share capital of HK\$2,025,000, being repurchased by the Company during the Relevant Period. An explanatory statement as required under the Listing Rules to provide the requisite information of the Repurchase Mandate is set out in Appendix I to this circular.

THE ISSUE MANDATE

As approved on the last annual general meeting of the Company held on 25 May 2018, a general mandate was granted to the Directors to exercise the powers of the Company to allot, issue and deal with Shares not exceeding 20% of the total number of Shares in issue as at the date of passing the relevant resolution. Such mandate will lapse at the conclusion of the AGM.

An ordinary resolution will be proposed at the AGM to grant the Issue Mandate in order to provide flexibility and discretion to the Directors to issue new Shares. As at the Latest Practicable Date, the Company has an issued share capital of HK\$20,250,000 divided into 2,025,000,000 Shares of HK\$0.01 each. Subject to the passing of an ordinary resolution approving the Issue Mandate and on the basis that no further Shares will be issued, allotted or repurchased by the Company prior to the AGM, the exercise of the Issue Mandate in full would result in up to a maximum of 405,000,000 Shares, representing 20% of the total number of Shares in issue and a share capital of HK\$4,050,000, being issued by the Company during the Relevant Period. In addition, an ordinary resolution will also be proposed to extend the Issue Mandate by adding to it the number of Shares repurchased under the Repurchase Mandate.

LETTER FROM THE BOARD

RE-ELECTION OF DIRECTORS

In accordance with Article 84 of the Articles, at each annual general meeting, not less than one-third of the Directors for the time being shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. The Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been longest in office since their last re-election or appointment and so that as between persons who became or were last re-elected Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot. Accordingly, Mr. Chen Jianqiang and Mr. Fung Hiu Chuen, John will retire by rotation at the AGM. All the above retiring Directors, being eligible, will offer themselves for re-election at the AGM.

Particulars of the Directors proposed to be re-elected at the AGM are set out in Appendix II to this circular.

ANNUAL GENERAL MEETING AND PROXY ARRANGEMENT

A notice dated 18 April 2019 convening the AGM to be held at 10:00 a.m. on Friday, 24 May 2019 at the Conference Room, 26th Floor, Wuxi Jinling Hotel, No.1 Xianqian East Street, Wuxi, Jiangsu, PRC, is set out on pages 12 to 16 of this circular.

Pursuant to Rule 13.39 of the Listing Rules, all votes of the Shareholders at all general meetings of the Company must be taken by poll except where the chairman, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. The chairman of the AGM will demand a poll for every resolution put to the vote at the AGM unless if there is any additional procedural or administrative matters to be voted at the AGM the chairman of the AGM may decide to allow such matters to be voted on by a show of hands.

A form of proxy for use by the Shareholders at the AGM is enclosed with this circular. Whether or not you intend to attend and vote at the AGM in person, you are requested to read the notice and complete and return the enclosed form of proxy in accordance with the instructions printed thereon and return it to the Company's Hong Kong branch share registrar, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong as soon as possible but in any event not less than 48 hours before the time appointed for holding the AGM or any adjournment thereof. Such form of proxy for use at the AGM is also published on the website of the Stock Exchange at www.hkexnews.hk. Completion and return of the proxy form will not preclude you from subsequently attending and voting at the AGM or any adjourned meeting should you so desire.

RECOMMENDATION

The Directors consider that (i) the grant of the Repurchase Mandate and (ii) the grant of the Issue Mandate to the Directors (and the extension thereto as described in resolution 9 as set out in the notice of AGM on pages 12 to 16 of this circular); and (iii) the re-election of retiring Directors, are in the interests of the Company, the Group and the Shareholders as a whole and accordingly recommend all Shareholders to vote in favour of all corresponding resolutions to be proposed at the AGM respectively.

This circular, for which the Directors collectively and individually accept full responsibility, includes particulars given in compliance with the Listing Rules for the purpose of giving information with regard to the Company. APPENDIX I EXPLANATORY STATEMENT ON THE REPURCHASE MANDATE

This appendix serves as an explanatory statement as required under the Listing Rules, to provide the requisite information to you for consideration of the proposed Repurchase Mandate.

SHARE CAPITAL

As at the Latest Practicable Date, the Company has an issued share capital of HK\$20,250,000 divided into 2,025,000,000 Shares of HK\$0.01 each.

Subject to the passing of the proposed ordinary resolution approving the Repurchase Mandate and on the basis that none of the outstanding share options granted under the Share Option Scheme is exercised and no further Shares will be issued, allotted or repurchased by the Company prior to the AGM, the exercise of the Repurchase Mandate in full would result in up to a maximum of 202,500,000 Shares, representing 10% of the total number of Shares in issue being repurchased by the Company during the Relevant Period.

REASONS FOR REPURCHASES

The Directors believe that the flexibility afforded by the Repurchase Mandate would be beneficial to, and is in the best interests of, the Company and the Shareholders as a whole. Besides, the ability of the Company to repurchase Shares would also be beneficial to the Shareholders who retain their investment in the Company since their proportionate interest in the Company's assets would increase as a result of such repurchases. Furthermore, depending on market conditions and funding arrangements at that time, such repurchases may lead to an enhancement of the net value of the Company and its assets and/or earnings per Share. Such repurchases will only be made during the Relevant Period when the Directors believe that such exercises will benefit the Company and the Shareholders as a whole.

FUNDING OF REPURCHASES

The Directors propose that the repurchase of Shares under the proposed Repurchase Mandate would be financed from the Company's internal resources.

In repurchasing the Shares, the Company may only apply funds legally available for such purposes in accordance with the Memorandum and the Articles and the applicable laws of the Cayman Islands. Under the laws of the Cayman Islands, repurchases of Shares by the Company may only be made out of profits of the Company or out of the proceeds of a fresh issue of Shares made for the purpose, or, if so authorised by the Articles and subject to the provisions of the Companies Law, out of capital. Any premium payable on a redemption or repurchase over the par value of the Shares to be repurchased must be paid out of the Company's profits or share premium account, or, if so authorised by the Articles and subject to the provisions of the Companies Law, out of the Company's capital.

The exercise of the Repurchase Mandate in full will not have a material adverse impact on the working capital or the gearing level of the Company (as compared with the position disclosed in the audited accounts of the Company for the year ended 31 December 2018 in the results announcement of the Company dated 25 March 2019).

APPENDIX I EXPLANATORY STATEMENT ON THE REPURCHASE MANDATE

The Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse impact on the working capital or the gearing level of the Company which in the opinion of the Directors are from time to time appropriate for the Company. The number of Shares to be repurchased on any occasion and the price and other terms upon which the same are repurchased will be decided by the Directors at the relevant time having regard to the pertaining circumstances.

TAKEOVERS CODE

If, as a result of any Shares repurchased by the Company, a Shareholder's proportionate interest in voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purpose of the Takeovers Code. Accordingly, a Shareholder, or a group of Shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

APPENDIX I EXPLANATORY STATEMENT ON THE REPURCHASE MANDATE

As at the Latest Practicable Date, the Directors are not aware of any shareholder or a group of shareholders acting in concert who will become obliged to make a general offer under the Takeovers Code as a result of the exercise of the Repurchase Mandate. Assuming that there is no further issue of the Shares between the Latest Practicable Date and the date of repurchase, the exercise of the Repurchase Mandate in full may result in less than 25% of the total issued share capital of the Company being held by the public as required by Rule 8.08 of the Listing Rules. The Directors have no present intention to exercise the Repurchase Mandate to the extent that less than 25% of the total number of issued Shares will be held by the public.

The following sets out the details of the Directors who will retire and, being eligible, offer themselves for re-election at the AGM pursuant to the Articles:

EXECUTIVE DIRECTOR

Chen Jianqiang, aged 61, is the founder and Chairman of the Group and has been appointed as the Chief Executive Officer in March 2018. He has been the executive Director of the Company since June 2006. Mr. Chen is responsible for the overall corporate strategy planning, business development, investment and day-to-day business and management of the Group. Since the Group's incorporation in 1996, Mr. Chen has been engaging in retail business and actively participating in the management and development of the Group's business. He holds an executive master's degree in business administration from China Europe International Business School. Mr. Chen is the chairman of honors of the World Chinese Traders General Association (Hong Kong) Ltd. (香港華商世界貿易總會).

Pursuant to the existing service contract between Mr. Chen and the Company, the appointment of Mr. Chen was for a term of 3 years commencing from 21 October 2016 subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Articles. Mr. Chen is the sole director and shareholder of Octopus Holdings Foundation, the controlling shareholder and an associated corporation of the Company. Save as disclosed above, Mr. Chen does not hold any other position in the Group and does not have any relationship with any other Directors, senior management or substantial or controlling shareholders of the Company. Mr. Chen has not and did not hold any directorships in any other public listed companies in the last three years preceding the Latest Practicable Date. As at the Latest Practicable Date, Mr. Chen is interested in 1,442,500,000 Shares representing approximately 71.23% of the issued share capital of the Company and 1 share in Octopus Holdings Foundation, the controlling shareholder and an associated corporation of the Company, which are required to be disclosed pursuant to Part XV of the SFO. The current Director's fee payable to Mr. Chen is RMB1,073,000 per annum, and may, subject to the discretion of the Directors, be reviewed. The remuneration package of Mr. Chen is determined by reference to his duty and experience and the prevailing market rates for executives of a similar position.

Save as disclosed above, Mr. Chen has no other information which are required to be disclosed pursuant to Rule 13.51(2) of the Listing Rules and there are no other matters that need to be brought to the attention of Shareholders.

APPENDIX II PARTICULARS OF THE DIRECTORS TO BE RE-ELECTED AT THE AGM

NON-EXECUTIVE DIRECTOR

Mr. Fung Hiu Chuen, John (馮曉邨先生), aged 51, was appointed as a non-executive Director in July 2010. Mr. Fung is member of the nomination committee and remuneration committee of the Company. Mr. Fung is currently the managing director of Global Link (CHINA) Company Limited, a company engaged in supply of TV media programmes. He had previously worked as a senior manager of the North Asia division of ESPN ASIA Limited, a diversified sports, entertainment and media company from 1995 to 1997. Mr. Fung holds a Bachelor of Science degree from Cornell University in Ithaca, New York, the USA.

Pursuant to the letter of appointment entered into between Mr. Fung and the Company, the appointment of Mr. Fung was for a term of 3 years commencing from 21 October 2016 subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the Articles. Save as disclosed above, Mr. Fung does not hold any other position with the Group and does not have any relationship with any other Directors, senior management or substantial or controlling shareholders of the Company. He has not and did not hold any directorship in any other public listed companies in the last three year preceding the Latest Practicable Date. As at the Latest Practicable Date, Mr. Fung does not have any interests in the Shares which are required to be disclosed pursuant to Part XV of the SFO. The current Director's fee payable to Mr. Fung is HK\$360,000 per annum, and may, subject to the discretion of the Directors, be reviewed. The remuneration package of Mr. Fung was determined by reference to his duty and experience and the prevailing market rates for executives of a similar position.
